# Part B: Review of outcomes in the previous academic year

#### Pupil premium strategy outcomes

This details the impact that our pupil premium activity had on pupils in the 2021-2022academic year.

Good progress and achievement was shown by all children in this group. Of the 17 children who received EYPP at some point in the year, 0% and 43% were working in age appropriate bands when Baselined. Between 50% and 82% were working in age appropriate bands at the end of the year. There were 5 EYPP children in the summer term, who were 2022 leavers.
